## **Salary Information**

Our research shows that upon graduation, Business grads earn an average salary range of \$35k-45k/year. Your specific salary will depend on the area you specialize in as well as your experience and skill level. This will increase as you gain experience in the industry. Many new grads start with higher salaries because they have gained related work experience while completing their degrees. This experience includes participating in Co-op work terms, part time jobs, summer internships, involvement with student club activities, and volunteering. With this experience, new grads are able to negotiate higher salaries. Over time, most Business grads can expect to earn very competitive salaries.
